Its modular structure allows practitioners and professionals to select specific courses/modules for specialized training under the à la carte modality while obtaining a participation certificate. Moreover, upon request, capacity-building activities are organized following specific requirements catered to beneficiary needs under the tailor-made modality.

Tuition Fees and Financial Aid

The standard tuition fee for EPLO's LLM in IEL for both EU and international students is 20.000€ including all program-related activities (such as field trips) and course materials. À la carte participants should request the updated list of per-course rates at info@aielpo.eplo.int

The AIELPO offers straightforward discounts as follows:

- **Early Bird discount** for full-time students: 15% discount will be provided to students applying before the 24th of May of the intake year. An additional 5% discount is provided to students who transfer the full tuition fees before the program starts.
- **Government officials:** 50% discount on full-time fees and 30% discount on à la carte fees. An additional 20% discount is offered to government officials from developing and least-developed countries.

Upon assessment of applications, the AIELPO extends the available discounts or tuition waivers to eligible applicants. An applicant entitled to several schemes will be awarded the most favorable waiver. AIELPO scholarships only cover full-time tuition fee waivers of 30%, 50%, and 70% granted to outstanding applicants demonstrating exceptional capabilities and financial need. Full scholarships are only reserved for a select number of highly qualified students from low and middle-income countries. Priority will be given to applicants from countries under war/armed conflict.
